Keynote: Marc Smith (École Nationale de Chartes)

Member of the French School of Rome from 1990 to 1993, he prepared a doctorate there from the Practical School of Advanced Studies on Italians discovering France in the sixteenth century: geography, travel and representations of space.

At the École Nationale des Chartes, he was first a lecturer and secretary general (1995-1998). He has also taught at the Paris-Sorbonne University and in several international institutions.

His research in palaeography generally focuses on the evolution of the Latin alphabet in its long-lasting cultural, technical and cognitive conditions, and currently on the engraved collections of master writers in modern times.

Sergio Torres (École Nationale de Chartes)

Sergio Torres Aguilar is a postdoctoral fellow at the École Nationale des Chartes. He obtained a doctorate in medieval history in 2019 at the University of Paris-Saclay. She has published and supervised research in the areas of Syntax, Historical Linguistics, Philology and Computational Linguistics.

Ana Margarida Dias da Silva (University of Coimbra, Portugal)

"The collaborative transcription project "Plant Letters": a corpus for palaeographers to study the uses and practice of manuscript reading".

Ana Margarida Dias da Silva is a PhD student in Information Science in the Faculty of Arts and Humanities of the University of Coimbra, with a Master in Information Science and Documentation – Specialization in Archivist, in the NOVA School of Social Sciences and Humanities – University NOVA of Lisbon (2013), and a Master in Contemporary History in the Faculty of Arts and Humanities of the University of Coimbra (2014).
